- All color separations, film preparation, film corrections, proof requests, stock and size variations, press approvals, additional bindery services, and final product delivery will be quoted individually and added to the listed prices. Please call for pricing specifics.
- All furnished film must be right - reading emulsion down composite negatives, and be accompanied by a color - correct proof produced from the films provided.** If this proof is not provided, the customer accepts full responsibility for the production costs and printed project including, but not limited to color, clarity, type, and print registration.
- Standard turnaround is 2 - 3 working days.** RUSH requests are handled according to the shop's workload at the time of the request. **RUSH JOBS ARE CHARGEABLE AT A HIGHER RATE THAN THE PUBLISHED RATE.** Please call for pricing specifics.
- Keylines must be complete. Position stats and tissue overlays indicating color and special instructions are required. **Color Express is not responsible for errors due to improperly prepared artwork.**
- All cost estimates, verbal or written are to be considered tentative until the job is in the shop. **All estimates are subject to revision upon evaluation of the actual art submitted. The customer will be notified of any changes prior to starting work.**
